

Grafton COVID-19 Emergency Rental Assistance Fund (Grafton CERAF)

Pre-Lottery Application Information

The Grafton Affordable Housing Trust (GAHT) has worked to create an emergency rental assistance program for income eligible Grafton residents having difficulty paying rent due to the COVID-19 pandemic. Rental assistance will be provided to selected Grafton renter households earning no more than 80% of the Area Median Income as listed below and meet all eligibility requirements. This Pre-Lottery Application will be utilized to rank applicants since it is anticipated funding may not be available to accommodate all eligible households. Eligible households selected in the lottery can receive up to 70% of their monthly rent with a maximum of \$2,000 per month, for up to three months. All funds will be paid directly to the landlord.

The gross maximum income for eligible households are listed below. Please be advised this income is for the entire household and is adjusted for household size, including all children or roommates.

Based upon your selected position in the Lottery, we will invite you to complete a full application and provide the necessary backup program documentation to confirm eligibility. Failure to provide accurate information in the Pre-Lottery Application may result in your removal from the program.

To be considered for the lottery, t*he Pre-Lottery Application must be submitted by* 11:59pm on *September 14, 2020.** The lottery will be held on September 17, 2020.* All applicants will be selected and ranked for full application review.

We have contracted with MCO Housing Services, LLC of Harvard, MA to administer the lottery and funding distribution on behalf of GAHT. These applications will be held solely by MCO Housing Services, LLC. You will receive a Lottery Code prior to the lottery and names will not be used in the lottery process to maintain your privacy.
